STARTING PAY: \$12.25-\$12.75 per Hour

Excellent Benefits: Paid Training, Full & Part Time Employees Accrue Paid Time Off at a rate of .038 PTO per hour worked (80 hours per year if working 40 hours per week).

Full Time Employees: 8 Paid Holidays, 2 Paid Personal Days, 401K at 2% Employer Match

Insurance Plans for Benefit Eligible Employees: Willows Way pays 75% of Employee Only Health Insurance Coverage with a Health Reimbursement Account (assists with deductible costs), 50% of All Dental Coverages.

We also offer Supplemental insurances i.e. Vision, Short Term Disability, Long Term Disability and more.

Realities CRC's support both individuals who live on their own and some who live at home with natural supports. CRC's may have up to 8 clients with whom they are assigned to visit and assist weekly. CRC's work a variety of daytime hours plus, at least, 2-3 evenings a week.

(Services vary and are based on the needs of the individual.)

QUALIFICATIONS

The Community Resource Coordinator (CRC) will:

- Be at least 18 years of age
- Associate's Degree, 60 hours towards (or) Bachelor's Degree in a Human Services field of study
- At least one year of service in the MR/DD or other disability or human service related field.
- Reliability, compassion, patience and a positive role model
- Good communication skills
- Flexibility in hours available: driving in the area to client's home(s), day and evening hours
- Excellent Time Management and Organizational Skills
- Ability to obtain knowledge of Community Resources in the St. Charles and/or St. Louis City
- Driver's License, car insurance and reliable transportation—position requires driving to multiple homes in the community daily, mileage (for client use) is reimbursed at \$.48 per mile

CORE RESPONSIBILITIES--(while driving to 2-4 homes per day)

- Monitor all aspects of home management and community participation of the individual supported
- Provide both physical and verbal guidance to individuals supported as requested or deemed appropriate to insure the highest quality of life
- Insure that optimal community inclusion is achieved, friendships are developed/nurtured, and individuals are living a life expressive of their own personal interests and choices
- Assist clients in areas of finances, health, residence, transportation, nutrition, socialization, and employment.
